<b>Renewal Options</b>	No automatic renewal. Default option is fully liquid with minimum 2% interest
<b>MVA</b>	Applied to withdrawals
<b>Annuitization Option</b>	After the first year. Surrender charges and MVA are waived over 5 years

<b>WITHDRAWAL CHARGES</b>										
During the Initial Guarantee Period and any Subsequent Guarantee Period, a Withdrawal Charge will be assessed if you make a withdrawal or surrender your contract, unless the surrender charge is waived as explained above.
